

## **CRYPTOUNIT Program Bonus Plan**

#### Terminology

- 1. **Bonus plan** plan of bonus accruals.
- 2. PAU paid accounting unit.
- 3. IAU internal accounting unit.
- 4. **Bonus** IAU accrual for personal work on increasing the sales of the club or the increase in the club's sales thanks to the work of the partner structure.
- 5. **PA** personal account of the user.
- 6. **Payment rate** internal exchange rate of the PAU for payment of the club's products in any currency.
- 7. Bonus rate internal rate of the IAU for conversion to any currency.
- 8. Unit AU (Accounting unit used to balance between CRYPTOUNIT INC. and partners of the CRYPTOUNIT program)
- 9. **PAF** Personally attracted Funds volume of increased Club sales as a result of your personal work on the promotion of the Club's products.
- 10. **FAP** Funds Attracted by Partners from your structure volume of increased Club sales as a result of your partner structure's work on the promotion of the Club's products.
- 11. Levels levels of your partner structure where the work on the promotion of the Club's products provides an increase in the sales of the Club's products.
- 12. Statuses Bonus Plan status of the partner. Status depends on the work done.
- 13. **Points for CRYPTOUNIT tokens** CryptoUnit tokens bonus units in the Electronic internal certificate in a specific EIP program, consolidated in the EIC on pre-order conditions (before the future release of the tokens of the same name, backed by the Global Investment Portfolio of the Club, after getting all of the necessary permits, licenses, conducting all procedures required by government agencies and international legalization practice in this sphere).
- 14. LOYALTY PROGRAM BONUS (LPB) Bonus received by the Club and distributed among each pre-ordered point for CRYPTOUNIT (CRU) tokens.
- 15. **PROFI BONUS (PB)** Special bonus accrued to each holder of points for CRYPTOUNIT (CRU) tokens in the amount of points/tokens.

We are open to transparent and mutually beneficial partner relations and will be happy to see you among our partners. There are 2 ranks and 8 statuses in the partner program:

#### Incentive items

• Does not have the opportunity to receive Partner program bonus accruals, as the terms of the Partnership agreement must be accepted for this.

### Qualification conditions

• You need to register in the personal account.

### Withdrawal of funds

• Not able to withdraw bonuses as personal funds.

## 2. Rank - Client

### Incentive items

• Has the opportunity to receive only LPB and PB bonuses from 05 to 10 of each month. It is necessary to accept the terms of the Club Membership agreement and its rules in order to receive LPB and PB bonuses.

### Qualification conditions

• Registered user who made a purchase for 50 units and more.

### Withdrawal of funds

• Does not have the ability to withdraw funds from the affiliate program.

### Partner Bonus

- 8% from personal sale in Units;
- 5% from sale on the 2nd level in Units;
- 3% from sale on the 3rd level in Units
- There are also accruals in points for CRYPTOUNIT (CRU) tokens (10% -100% of the percentages indicated in each level of the CRYPTOUNIT Bonus Plan, depending on the stages).

**Example**: for personal sales, you are credited with 8% in units and 8%-0,8% in points for CRYPTOUNIT (CRU) tokens from the received points for CRU tokens of your personal client, who made the purchase based on your personal recommendation. (Also works for your partners)

- Bonuses are credited to the Bonus and Point accounts.
- LPB and PB are credited to the Bonus Account.

• Has the opportunity to receive as a member of the Closed Club LPB and PB from 05 to 10 of each month after entering the CRYPTOUNIT program for each received bonus point for CRYPTOUNIT (CRU) tokens

### Partner Bonus

- 8% from personal sale in Units;
- 7% from sale on the 2nd level in Units;
- 4% from sale on the 3rd level in Units;
- 3% from sale on the 4th level in Units;
- There are also accruals of points for CRYPTOUNIT (CRU) tokens

(10% -100% of the percentages indicated in each level of the CRYPTOUNIT Bonus Plan, depending on the stages).

**Example:** for personal sales, you are credited with 8% in units and 8%-0,8% in points for CRYPTOUNIT (CRU) tokens from the received points for CRU tokens of your personal client, who made the purchase based on your personal recommendation. (Also works for your partners).

• Has the opportunity to receive as a member of the Closed Club LPB and PB from 05 to 10 of each month after entering the CRYPTOUNIT program for each received bonus point for CRYPTOUNIT (CRU) tokens

### Partner Bonus

- 8% from personal sale in Units;
- 7% from sale on the 2nd level in Units;
- 5% from sale on the 3rd level in Units;
- 4% from sale on the 4th level in Units.
- 3% from sale on the 5th level in Units.
- From 2,0% to 3,5% from sale on the 6th level and to infinity in Units
- There are also accruals in points for CRYPTOUNIT (CRU) tokens

(10% -100% of the percentages indicated in each level of the CRYPTOUNIT Bonus Plan, depending on the stages).

**Example:** for personal sales, you are credited with 8% in units and 8%-0,8% in points for CRYPTOUNIT (CRU) tokens from the received points for CRU tokens of your personal client, who made the purchase based on your personal recommendation. (Also works for your partners).

  - to receive 2,5% in units personally attract the 1st Consultant to your 1st structure;
  - to receive 3,0% in units personally attract the 2nd Consultant to your 2nd structure;
  - to receive 3,5% in units either attract the 3rd Consultant to your 3rd structure or help a consultant from your 3rd structure grow on any level;
  - As soon as you have 2 personally attracted consultants and 2 consultants in the 3rd or 4th structure you become a Manager and receive 4% from the 6th level and to infinity.

\*\*\* interest from 2% to 3,5% from the 6<sup>th</sup> level to infinity are distributed depending on the number of consultants in your first line or in the 3<sup>rd</sup> and 4<sup>th</sup> and more structure, these conditions can be known only by qualified Statuses from Consultant and above during the special training for consultants

- 3% from sale on the 5th level in Units.
- From 4 % to 5,5% from sale on the 6th level and to infinity in Units
- There are also accruals in points for CRYPTOUNIT (CRU) tokens

  - to receive 4,5% in units personally attract the 1st Manager to your 1st structure;
  - to receive 5,0% in units personally attract the 2nd Manager to your 2nd structure;
  - to receive 5,5% in units either attract the 3rd Manager to your 3rd structure or help a manager from your 3rd structure grow on any level;
  - As soon as you have 2 personally attracted Managers and 2 Managers in the 3rd or 4th structure you become a Leader-Manager and receive 6% from the 6th level and to infinity

\*\*\* interest from 4 % to 5,5 % from the 6th level and to infinity is distributed depending on the number of Managers in your first line or in the 3rd and 4th and more structure these conditions can be known only by qualified Statuses from Consultant and above during the special training for consultants

- 7% from sale on the 2nd level in Units;
- 5% from sale on the 3rd level in Units;
- 4% from sale on the 4th level in Units.
- 3% from sale on the 5th level in Units.
- From 6 % to 7% from sale on the 6th level and to infinity in Units
- There are also accruals in points for CRYPTOUNIT (CRU) tokens

(10% -100% of the percentages indicated in each level of the CRYPTOUNIT Bonus Plan, depending on the stages).

  - to receive 6,35% in units personally attract the 1st Leader-Manager to your 1st structure;
  - to receive 6,7% in units personally attract the 2nd Leader-Manager to your 2nd structure;
  - to receive 7,0% in units either attract the 3rd Leader-Manager to your 3rd structure or help a leader-manager from your 3rd structure grow on any level;
  - As soon as you have 2 personally attracted Leader-Managers and 2 Leader-Managers in the 3rd or 4th structure you become a Top-Manager and receive 7,4% from the 6th level and to infinity

\*\*\* interest from 6 % to 7,0 % from the 6th level and to infinity is distributed depending on the number of Leader-Managers in your first line or in the 3rd and 4th and more structure these conditions can be known only by qualified Statuses from Consultant and above during the special training for consultants

- 7% from sale on the 2nd level in Units;
- 5% from sale on the 3rd level in Units;
- 4% from sale on the 4th level in Units.
- 3% from sale on the 5th level in Units.
- From 7,4 % to 7,8% from sale on the 6th level and to infinity in Units
- There are also accruals in points for CRYPTOUNIT (CRU) tokens

(10% -100% of the percentages indicated in each level of the CRYPTOUNIT Bonus Plan, depending on the stages).

\*\*\* interest from 7,4 % to 7,8 % from the 6th level and to infinity is distributed depending on the number of Leader-Managers in your first line these conditions can be known only by qualified Statuses from Consultant and above during the special training for consultants

- From 8,2 % to 8,6% from sale on the 6th level and to infinity in Units
- There are also accruals in points for CRYPTOUNIT (CRU) tokens

- to receive 10,0% in units and in CRYPTOUNIT tokens personally attract a President to your third structurel;

\*\*\* interest from 9,1% to 10,0 % from the 6<sup>th</sup> level and to infinity is distributed depending on the number of Presidents in your first line these conditions can be known only by qualified Statuses from Consultant and above during special training for consultants
